# Charlie's Ready for Summer Break!

Charlie, 11, and her older sister, Riley, 15, have lived with their grandmother in Big Sandy since 2019. Three years ago, Charlie and Riley experienced a tragedy no child should have to endure: the sudden loss of their mother.

There is still grief, but the girls' grandmother loves them dearly and is raising them now. They've also found support at school and through Big Sandy Christian Community Outreach Center (CCOC), a Second Harvest Partner Agency in Benton County.

CCOC is a daily afterschool program where kids can come for a hot meal, homework assistance, and fun, enriching learning projects. It's also open during the summer when kids don't have access to school meals.

"The food is really good," Charlie says. "The hamburgers are my favorite."

This resource for fun, education, and healthy food is available thanks to generosity from friends like you.

Charlie's already anticipating her time at CCOC this summer. There, she'll join fun community service projects like collecting aluminum cans to redeem for money to put toward local water bills. And of course she loves the healthy, delicious food.



### HISTORIC AFRICAN AMERICAN CHURCH FIGHTS HUNGER

Ten years ago, Authur and Jeanette Phelps started the food ministry at St. Paul Missionary Baptist Church, a Second Harvest Partner Agency in Decatur County. Twice a month, the church provides fresh produce, meat, dairy, baked goods, and pantry items to people facing hunger in their community.

"This church is 200 years old and was part of the Underground Railroad," said Authur. "We are one of the few historic African American churches in this area, and we have been blessed to serve this community for so many years."



### OUR COMMUNITY FIGHTS HARDER THAN EVER FOR NEIGHBORS FACING HUNGER

Providing food to neighbors who need it is hard work, especially during a global pandemic. Volunteer Elyse has been sorting and packing food with us since early 2020, saying, "Families are struggling to put food on their tables during these difficult times."

### WHY WE'RE INDISPENSABLE

Massive quantities of food get dumped into landfills, yet 1 in 8 Middle Tennesseans is at risk of hunger. This is partially a logistics problem. Thanks to our donors and volunteers, we have the space and the manpower to manage large shipments, break them into smaller units, and send them at the right time and in the right quantity to our network of Partner Agencies across 46 counties.

## You Make a Difference for Neighbors Like Lou

Lou lives in Chapel Hill with her husband, who is a farmer. Lou worked in the food service industry for more than 27 years. The couple considers themselves extremely hardworking and, usually, self-sufficient.

Unfortunately, Lou was forced to retire early after a back injury and two subsequent surgeries. With only one income, Lou and her husband are trying hard to get by, but the rising cost of living and mounting medical bills are making it difficult.

The couple knew they needed help, but, Lou says, "Asking for help is hard, especially when you're used to taking care of yourself."

When Lou was young, she was adopted through the foster care system, and she recognizes the power of helping and taking care of others. The nutritious food she receives at the Second Harvest Mobile Pantry at Mt. Carmel Missionary Baptist Church reminds her of this kindness she received as a child.

"I know how it feels to finally find somebody that loves you and is able to take care of you," she says. "That is what people are doing right here – working together, loving one another, embracing one another, caring for one another."

Your support is a real source of kindness and warmth for Tennessee neighbors like Lou and her husband. Thank you for being there for our community members who would otherwise face hunger without your generosity.

### Donor-Advised Fund Allows the Rodens to Give Back Tax-Free!



Maisie and Dan Roden like to donate to organizations that fill an important need in the community. "Second Harvest meets an obviously important need and is one of our priorities," Maisie says.

One way they give is through their Donor-Advised Fund, or DAF. A DAF is like a charitable savings account with several tax benefits. Your donation goes further with a DAF, as dollars that would have gone to taxes can go directly to feeding those affected by hunger in Middle and West Tennessee.

You also receive a federal income tax charitable deduction for the amount you deposit into your DAF.

Maisie says, "We like to use our Donor-Advised Fund because it makes giving easy at any time during the year."

# Xayne Eats Good Food to Grow Strong

**W**hen we met Xayne, 6, he had just completed kindergarten and was a soon-to-be first grader. Xayne loves sports and his favorite parts of school are recess and PE. He and his big brother, Xaidyn, want to be professional football players when they grow up.

“I’m a fast runner and can run for a very long time,” Xayne says with pride.

But when school is out, kids like Xayne, who rely on free and reduced-price cafeteria meals during the school year, lose access to this nutritious resource. His parents will have to make up the difference and come up with 10 extra meals each week *per child*.

For some households, budgets will reach a breaking point.

Fortunately, Xayne attends Dream Streets, a Second Harvest Partner Agency that hosts a Summer Food Service Program (SFSP). SFSP sites help ensure low-income children

continue to receive nutritious meals even when school’s not in session.

Volunteers set up games and activities for local kids and serve tray-pack meals provided by Second Harvest. These sites are open five days a week and serve children living in nearby communities.

Xayne loves healthy food. His favorite meal is a big salad with lots of protein and ranch dressing.

“I like to eat good food because you can stay strong and feel good,” he says.
